## **OUR MISSION**

Our mission is to raise awareness among parents on the early signs of Autism Spectrum Disorder (ASD) in infants and babies.

Autism Spectrum Disorder (ASD) can be detected as early as 18 months of age provided that parents monitor their child's development. Typically, children are not diagnosed until after they have entered elementary school. At this point, they have missed years of critical intervention and assistance which they qualify for.

We advocate resources that educate parents, as early as pregnancy on the developmental milestones of infants, and babies. This project is created by Sabram Enterprises to raise awareness, and promote early detection of autism spectrum disorder – ASD in, toddlers and children.

In 2021, the CDC reported that **approximately 1 in 44 children** in the U.S. is diagnosed with an autism spectrum disorder - ASD, according to 2018 data. Boys are four times more likely to be diagnosed with autism than girls.

Access to information on the early detection signs of Autism Spectrum Disorder - ASD can help internal as well as external family circles, get the conversation started with the parents of the child.

#### AUTISM NAVIGATOR COURSE LICENSE

The Spectrum NFT is the property of Sabram Enterprises. Our goal is to sponsor the \$500, 1-year licenses that give access to; <u>Autism Navigator How-To Guide For Families</u>.

This interactive web-based course is for families who suspect their toddler has autism or a social communication delay. It will put in the hands of families hundreds of video illustrations of evidence-based intervention techniques that they can implement in everyday activities to support their child's learning as soon as they suspect autism.

This interactive program will teach families how to embed strategies and support into their everyday activities, provide developmental growth charts to help families recognize and monitor meaningful outcomes, and offer a video library to illustrate how to promote learning and development for toddlers with ASD.

The course will also be instrumental for early intervention providers to use with families in early intervention to improve outcomes for toddlers with ASD and their families.

# SPONSORSHIP PROCESS

#### APPLICATION

Sponsorship application will begin Q3 2022. It will come with rules and requirements to ensure that it goes to families who will benefit from the Autism Navigator course.

The reward is **non-monetary**. We will directly pay and assist awardees with signing up for the platform.

#### SPONSORSHIP AWARDING

Sponsorship of the \$500 annual license of the Autism Navigator How-To Guide For Families will be awarded on a quarterly basis, starting in Q3 2022. There will be a live social media Zoom event announcing the name of the selected applicants. Those who consent to appear live at the Zoom event will be featured.

## NFT SALES INFORMATION

#### **BLOCKCHAIN**

The Spectrum NFT will be on the Ethereum (ETH) blockchain. As such, you will need ETH to cover the gas fees of the purchase

#### **PURCHASING**

You can link your Metamask wallet directly to our website and acquire the NFT. You can also buy your NFT using your debit card! You can check out using our mint service and allow up to 24 hours for delivery. You **MUST** provide your Ethereum crypto wallet address at checkout.

## NFT SALE DISTRIBUTION

Revenue from each initial sale of The Spectrum NFT will be distributed amongst 3 wallets. A portion of each re-sale of each NFT will go towards 1 wallet. A monthly withdrawal will be made at the first of each month, to go towards the work administering the project. The rest remains towards Donations.


#### INITIAL SALE DISTRIBUTION

- 20% of all revenue will go to the Gold Standard Group (GSG). They are a group of Blockchain & NFT Developers and are our partners in the deployment of The Spectrum.
- 40% of all revenue will go to Organizers & Management of The Spectrum NFT
- 40% of all revenue will go into a Donations wallet. This wallet will be used to provide
   Sponsorships and other outreach efforts for the Project.

#### **DONATIONS WALLET ADDRESS**

Funds for the initial sale will arrive in ETH. We plan to keep it as ETH unless we notice a large enough drawdown in ETH's value to warrant converting it into USDC to maintain enough dollar value

#### **RE-SALE DISTRIBUTION**


 - 10% of the value from a re-sale of The Spectrum NFT will go back towards supporting the project. This will be viewable in a separate address made available for viewing on Blockchain Explorer.

- 30% of the 10% will go back to the Organizers & Management of The Spectrum NFT.
   Withdrawals of the 40% will be made at the beginning of each month and will show on the Blockchain Explorer.
- 70% of the 10% will go into a second Donations wallet. This wallet will be used to provide Sponsorships and other outreach efforts for the Project.

#### SALES TRACKING

Our website will track and show NFT Sales statistics. It will be done on a weekly basis manually. We will keep track of the number of sales occurring directly over the blockchain and also sales are done through our Minting Service.

We make the address allocated for Donations public, so one can always verify for themselves on the blockchain explorer how our sales are performing versus the circulating supply.


### PURCHASE NFT WITH DEBIT / CREDIT CARD

We will allow the usage of Debit / Credit Cards to purchase an NFT as a Minting Service, however, we will need up to <u>24 hours</u> to deliver the NFT. We charge extra on the Minting Service to account for:

- Fees incurred to purchase the ETH
- Withdrawal fees to send the ETH to our Metamask wallet
- Minting fees
  - This can be the most costly part. ETH network fees can range spike in cost, with sample minting costs ranging from \$39 to \$100. We will mint at the times with the least fees.
- Withdrawing the NFT from our Metamask to your ETH wallet

## **ROADMAP**

The following is a roadmap for the next year.



#### PRIMARY OBJECTIVE

Our main objective is to have enough initial sales to fund our first Sponsorship by Q3 2022. Autism Navigator is the primary program that we intend to sponsor, however, we will also research other programs. If we reach our sales target earlier than expected then we will start the Autism Navigator Sponsorship earlier than Q3 2022.

When we award families with the scholarships, with their permission, we will film and feature them on our website.

#### COMMUNICATION

Our direct line of communication will be the Telegram App, the link to join our chat will be published on our chat. It will be a place to discuss and answer questions about the project.

For key milestones such as awarding families with Sponsorships, we will publish the videos on our YouTube channels.

To find the families to award the sponsorships to, we will join various online groups for parents with children on the autism spectrum. We will also reach out to regional centers.
